OLD BUSINESS: NCNBF 2ND VICE PRESIDENT ELECTION

- □ *Background*: Greg had previously asked the Board of Directors to consider reviewing and possibly revising the current readjustment process. Currently, bowlers whose averages have been adjusted, are notified by the Tournament Directors. In order to achieve consistency and an even "play field", Greg is recommending that the responsibility of notifying bowlers of any average adjustments should come from the NCNBF and not from the Tournament Directors. Everyone was asked to report back to their Association for any ideas/feedback.
- □ A recommendation was made to compile a letter to send to all Tournament Directors next season. The information in this letter shall include the purpose and expectations regarding the readjustment process.
- □ The Board of Directors agreed that the readjustment process and its pros and cons be discussed further at the next meeting.

NEW BUSINESS: SAN JOSE NIKKEI BOWLING ASSOCIATION (SJNBA)

- □ Greg reported he recently spoke with a San Jose Non-Nisei bowler who had informed him that they were not offered the opportunity to purchase the 2006-07 NCNBF membership card. Greg was also informed by this person that he did not know that the SJNBA withdrew their membership from the NCNBF.
- □ Greg informed the Board of Directors that he personally delivered the 2006-07 NCNBF membership cards to Marc Tsuchiya (SJNBA President) in December, 2006. Greg also informed the Board that he recalls informing Marc that if anything, their Non-Nisei bowlers should purchase a card to maintain their eligibility status.
- □ It was noted that SJNBA Non-Nisei bowlers who have not purchased a 2006-07 NCNBF membership card may not be eligible to bowl in some of the NCNBF tournaments next season.
- □ Greg will contact Marc to inform him it is not too late to purchase cards.
