UPDATE - BOWLER DATA FEEDBACK

☐ Mark Yoshinaka announced that so far the only Associations who have submitted
bowler information to him for the current season are: Tri-City, Sacramento and Gilroy.
☐ Mark will contact Statistician, Lori Neishi-Wong to see if she has received anything
from the other Associations and report back to the Board.
☐ Mark will send to all Association representatives, via e-mail, a draft of a letter that
details the changes made to NCNBF operations during the summer of 2009. In this letter
it will also explain why the collection of bowler information has changed. Associations
will have until January 16th to provide feedback. The contents/outcome of this letter will
be discussed at the next meeting.

NCNBF DATABASE DISCUSSION

☐ Accessibility

- There was discussion about whether to restrict access to ALL databases on the NCNBF website.
 - ✓ It was decided that access to the database(s) will be restricted to only tournament chairs and other authorized NCNBF members (i.e. Association representatives, Line Officers, etc).
 - ✓ This may ease some of the privacy concerns expressed by some of the Associations.
- ☐ Member Information Database
 - Contents
 - ✓ USBC number
 - ✓ First and last name
 - ✓ Nisei association
 - ✓ Current book average
 - ✓ Previous year's book average
 - ✓ Eligibility (Nisei, Non-Nisei, Non-Nisei married to Nisei)
 - ✓ Gender
 - ✓ Link to tournament performance

☐ Discussion

- It was discussed as to whether we need to/or should include the averages in the database.
- Most tournament chairs verify averages through BOWL.COM but because their interface is not the "cleanest", some Associations said that if we, the NCNBF, could verify the averages submitted by the Associations through BOWL.COM,

that would definitely be a value-add that the tournament chairs would find worthwhile.

✓ It was decided starting summer 2010; the NCNBF Statistician (with help from the Board) would be responsible for verifying bowler averages. We would need a signed document from the NCNBF Statistician stating the averages in the online database are correct and have been verified.
