- Access Restrictions
  - There is no link to this section from the main NCNBF website. There is also a mechanism in place that tells the search engines to "go away"
  - Everything in the "members" directory will be password protected...however, password protection will be the last thing implemented before the database goes "live"
    - Doing it this way makes testing the various components a whole lot easier
- Searching and Displaying Results
  - All major search functions have been implemented
    - Search by: Association, USBC#, Name and Last Name pattern Matching (i.e. last name starts with...)
  - Results page created
    - Will display, full name, USBC#, Association, current and previous year's book average, eligibility and gender
- Database Tools
  - Currently implementing a navigation bar "add new member" and "edit member info" functions. These should be done shortly.
  - "Delete member" function possible but not until later or there's demand for such a function.
  - Only the Webmaster, Database Administrator (currently same as Webmaster) and NCNBF Statistician (Lori Neishi-Wong) will be able to modify the database once access restrictions are implemented. Association Reps and Tournament Chairs will have to contact either Lori or Mark to request changes.
  - The "Next Steps"
  - Complete the "edit member info" function
  - Gather what needs to go into the "Tournament" database and what functions the Tournament Chairs would like

# <u> UPDATE – BOWLER DATA FEEDBACK\_</u>

□ Bowler Information Received

#### NCNBF DATABASE DISCUSSION\_

□ Membership Database

- For the book averages, change database field type from integer (number) to text. This allows us to note summer averages when bowler has no winter average.
- $\Box$  Tournament Database(s)
  - Mark will work on defining the database(s) based on discussions he had with Darren. They will be presented at the next meeting.
  - Individual game scores vs. series
    - During the discussion, Tournament Chairs said they could provide the individual game scores while others were not sure. Also, there was a concern that going to this level of detail could significantly increase the amount of work that the NCNBF would have to do. The consensus was that, for now, we just ask for the 3-game series scores for each event bowled however, the data base will be set up so it could accept individual game scores at some point in the future.
  - Tournament Chairs that were present requested the following features
    - Searching for a specific bowler (via USBC# or name)
    - "Specialized Search" (examples below)
      - List all bowlers who's tournament average > entering average by X pins
      - List all bowlers who won prize fund money
      - Other criteria (TBD by tournaments)
  - Tracking of Side Pot Winnings
    - During the discussion, some Associations say they track this while others don't. There is also the potential for this to be a lot of work for the Tournament Chairs because besides tracking how much bowlers win, they will have to track how many times the bowler gets in the side pots.
  - Getting Tournament Scores into the Database
    - The NCNBF would have to request/require that the Tournament Chairs have to get the scores into the NCNBF as soon as possible so the next tournament would have that data available to them. With our current tournament schedule, there is usually about a month in between

tournaments so we would need scores within 2 weeks of the completion of the tournament

- Tournament Database Fields (got these mostly from Darren, subject to change)
  - Tournament General Information Database
    - Tournament Name and Year (possibly combined into an alphanumeric code)
    - Bowler's Name and USBC#
    - Entering Average, Tournament Average, Difference
    - Was bowler adjusted
    - Type of oil pattern used
  - Tournament Scores Database
    - Tournament Name and Year (from General Information Database)
    - Bowler's Name and USBC# (from General Information Database)
    - Event Type (doubles, singles, team)
    - Game Scores
    - Series
    - Prize fund won (yes or no, if yes, then how much)
