RULES:

1. Unless otherwise specified, rules for the 39th Annual Eden Nisei Invitational Doubles tournament will apply.
2. **A team will consist of one (1) woman and one (1) man. (limited to men bowlers 60 and older and women bowlers 55 and older.)**
3. One member of team must be Nikkei.
4. Prize fund will be returned 100%.
5. The “Senior Mixed Doubles event and Regular Doubles event are separate tournaments with separate prize fund and pot games.
6. No minimum entering average for men or women.

EDEN NISEI 2010 TOURNAMENT RULES

1. Open to all Nisei Bowlers (bowlers of Japanese ancestry).
2. Non-Nisei bowlers accepted in a NCNBF recognized Nisei league/association must be active members in that league/association. Where question of eligibility arises, the decision of the tournament committee shall be final.
3. This tournament shall be morally certified under USBC Rule 301. Unless otherwise specified, USBC rules and regulations will govern situations not covered by the tournament rules. Participants must be USBC members to qualify for USBC awards.
4. A non Nisei bowler who has bowled at least 2/3 of the current seasons league games in a recognized league or association as of the tournament entry deadline shall be eligible for tournament play. The tournament committee is to have final decision on its participants.
5. Tournament entering average shall be:
 - A. Highest 2008-2009 book average.
 - B. Highest 2007-2008 book average with 5-pin drop rule in effect.
 - C. If none of the above, the highest known current USBC league average, 21 games or more as of tournament entry deadline. Proof must be furnished.
 - D. If none of the above, bowlers must bowl scratch: 220 for men, 220 for women. Minimum entering average for men 150, women 125.Five-pin drop rule to be interpreted as follows:

If current book average is lower than previous year's 2007-2008 by five pins or less, current book average will be used. If current book average is six or more pins lower than previous year's book, use previous year's book less five pins.
6. Except where noted, the following will apply to all participants:
 - A. USBC Rules 319A, (1), (3) and (5) applies. Rule 319A (2) and (4) does not apply. USBC Rule 319d applies . USBC 319e does not apply.
 - B. Bowlers whose total prize winnings was \$350.00 or more (including team event) in one or more tournaments during the past twelve months preceding the tournament start date, may be adjusted per NCNBF Form 101 Amendment 5.

NOTE: Rule 319C shall in no way supercede the tournament manager's authority to adjust a bowler's entering average when evidence indicates that the bowler's skill is not coincident to his book average. Such rerating must be accomplished before the entrant bowls, however, if the rerated average is not accepted by the bowler the entry fee shall be refunded.
 - C. The 5-pin drop rule is not applicable if within the scope of the specified time limit, a bowler's total prize winnings was \$250.00 (men), \$200.00 (women) or more. Adjustments will be based on 2007-2008 or 2008-2009 book average, whichever is higher.
7. Handicap shall be based on 80% of 220 for men and 90% of 220 for women.
8. **Average verifications, NCNBF Form 102, must be submitted to the tournament committee with entry. *League sheets will not be accepted as an average verification.***

Exception: An extension, not to exceed 48 hours after completion of first series bowled may be granted by the appropriate chairperson.

Bowlers with unverified averages will be adjusted to 220 (men) and 220 (women).
9. **Entrants may bowl as often as they wish, but not more than once with the same partner. Teams may be either mixed, both women, or both men. There shall be no restrictions on two non-Nisei bowling together who qualify by above Rules No. 1 through 4.**
10. Tournament committee decisions will be final. Appeals must be made in accordance with USBC Rule 329
11. **Time preference will be based on entries received on a first come first serve basis.**
12. Prize list shall be posted before start of tournament. One hundred percent of prize fund shall be paid and distributed within 30 days of close of tournament. Ratio of prize fund will be at least one per eight entries.
13. Each entry form with average verification not completely filled in nor properly signed shall be rejected. Entry fee must accompany all entries.
14. In case of a tie, cash prize will be divided equally.
15. All bowlers entered must report at least thirty minutes before squad time of check-in and report any substitutions on the roster. No changes in the order of bowling shall be permitted.
16. All bowlers shall be properly attired and live up to the good sportsmanship Nisei bowlers have established.
17. Above rules pertaining to singles and team not applicable to this tournament.
18. Tournament chairpersons have the right to adjust any bowler's average
19. GENERAL NOTES:
 1. All bowlers average who have been adjusted must report it to the tournament committee.
 2. **ONE LANE COURTESY WILL BE OBSERVED.**
